President's Report

As President it is very easy to become gloomy about the Society and its future and also to be frustrated by the inactions of members. One is constantly assailed by thoughts such as "How much more could be achieved if only everyone did just a little".

But the world we live in is divided into doers and followers with the latter outnumbering the former. I am not even sure how true the division is, because surely it cannot be the same group of people that do all the doing in the world. People probably take different roles in different parts of their lives. If my own situation is anything to go by this is true. I belong to a veterans cycling club, and I am occasionally asked join the committee, look after our equipment van or some other role in running the club. However with my commitments to the EntSoc and on the committee of my kids' little athletics club, I feel I am already doing my fair share of extra-curricular participation. I tell my cycling mates to be patient, I'll have some time eventually. In the mean time, I say to them, corner a couple of those SKI'ers or DINK's riding the \$10,000 bikes.

Perhaps the same is true for the many of our members who take no active role in the running of the Society. They may simply be overcommitted already.

But I am glad I took the plunge and joined the EntSoc Committee. It was probably the first committee I joined. In fact, I intend to get involved in any organisation I become involved in. Becoming a participator in a club or society or any group for that matter is like metamorphosing into another being. A new world awaits those who make the journey. You go from becoming invisible to taking part in inventing the future. You learn things and you get to meet effective, positive people.

2006 was another mixed one for the Society. We are still here. Our members seem to be happy paying their fees. We have meetings. We put out a Journal and a Circular.

On the other hand a lot of members are behind on their subscriptions. The majority of members don't attend meetings and it can be a struggle to find quality papers for the Journal. Recently a long-serving member told me that the Society had always been clouded by a sense of impending doom. So I guess there is nothing to worry about.

I'll briefly run through some aspects of the EntSoc's operations in 2006.

Finances

For the past few years the Society's finances have been a source of concern. While our revenue base remained relatively static, costs burgeoned. As you would probably be sick of hearing, the major new costs were the venue hire and insurance.

In 2003 we made a net loss of \$5149.92, in 2004 we lost \$1644.44 and in 2005 we lost \$2817.28.

As you heard tonight from the Treasurer, this year we had an operating surplus of \$913.99.

This is a great result and stems primarily from actions taken by Council over the past 3 years to address the deficit. Not the least effective of these measures was the decision 2 years ago to increase the cost of membership. I thank members for the forbearance shown in accepting the increase.

The Society must remain on guard to prevent any rundown in its finances. While there appear to be no looming threats to the budget, opportunities to reduce cost and enhance revenues must be constantly explored.

This year Council discontinued the use of an external auditor to examine our accounts. This decision will save around \$500 each year. While not having an external audit has attendant risks, spending almost 10% of our revenue to ensure that that revenue was not misused could not be justified.

Another initiative to enhance revenue is the investment of a portion of our funds in a term deposit account. Until this year our funds were in a cheque account earning minimal interest. The investment will produce an annual return of around \$250.

For the first time in Society's history, to my knowledge at least, a budget has been prepared for the coming financial year. This predicts a very small operating loss for 2007. My thanks to Ted Taylor for preparing the budget and for his considerable ongoing efforts as the Society's Treasurer.

Membership

Membership of the Society declined from 123 in 2005 to 111 in 2006. While on the surface the decrease appears large, most of the members lost were un-financial. The number of financial members dropped by 2, from 96 to 94.

Amazingly, until a couple of years ago, the Society did not have an up to date electronic record of our membership. Fortunately this has now been addressed. It is essential that a single master copy is maintained and not allowed to become out of date. The Society must ensure that the maintenance of this record becomes one of its highest priorities.

Attendance at Meetings

Attendances at meetings in 2006 averaged 17.5, up from 15.5 in 2005 and 13.25 in 2004. One factor leading to the increase has been advertising. Through the issuing of an email flyer before meetings, we now inform non-members about our meetings. An area where we still fall down and see an opportunity to attract new people go begging is our failure to maintain an effective web site. The construction and maintenance of a site should become another top priority for the Society.

Circular

As you will all have noticed, for the past year, publication of the Circular has been in the expert hands of Simone McMonigal. Under Simone the Circular has become world-class. Unfortunately Simone will be resigning from her position this year.

Journal

In 2006 volume 35 of our Journal *General and Applied Entomology* was published. Once again Garry Levot did an excellent job cajoling authors and reviewers to see that the Journal not only had content but was of high quality and was published in a timely way.

I wish to express my thanks to all members of the 2006 Council for their efforts throughout the year.

Aussie mozzies cause cockpit chaos on NZ flight

Six potentially disease-carrying mosquitoes swarmed through the cockpit of a Christchurch-bound plane on Sunday, biting an Australian pilot before being destroyed. Three mosquitoes were squashed before the flight from Brisbane landed at Christchurch International Airport and another three were destroyed after arrival in the hangar. Authorities say the invading insects were intercepted so posed no risk to the public.

Public health officers have since laid mosquito traps at the airport's No. 1 hangar - water-filled tyre traps to catch larvae, and light and carbon dioxide traps to catch adults. The exotic mosquitoes arrived on a Boeing 737 being flown to Christchurch for engineering work. No passengers were on board. Medical officer of health Alistair Humphrey would not say which airline operated the plane.

The two species found by public health officers are both common in Australia - *Aedes vigilax* and *Culex sitiens*. Both can be carriers of the Ross River virus, which can cause fever. The latter may also infect bite victims with Murray Valley encephalitis, a potentially devastating brain disease.
